



LEISURE WORLD LOCAL RULES COYOTE RUN GOLF COURSE

- ALL WATER HAZARDS (PENALTY AREAS) ARE LATERAL. THE WATER'S EDGE DEFINES THE
 HAZARD LINE, UNLESS MARKED BY HAZARD STAKES. THE CONCRETE BORDERS ON #6 AND #18
 ARE MAN MADE. YOU ARE ENTITLED TO FREE RELIEF IF THESE BORDERS INTERFERE WITH YOUR
 SWING OR STANCE.
- 2. IMMOVABLE OBSTRUCTIONS: YOU MAY SEEK RELIEF IF ANY OF THE FOLLOWING INTERFERE WITH YOUR STANCE OR SWING ONLY, NOT LINE OF FLIGHT. STAKED TREES, CART PATHS, BRIDGES, CONTROL BOXES, RESTROOMS, FRENCH DRAINS, AND CULVERT AREAS. YOUR RELIEF IS ONE CLUB LENGTH FROM THE NEAREST POINT OF RELIEF NO CLOSER THE HOLE. THIS DOES NOT INCLUDE TREE WELLS THAT ARE NOT STAKED, OUT OF BOUNDS MARKERS OR BOUNDARY FENCES, YOU MUST PLAY THE BALL AS IT LIES WITHOUT RELIEF.
- IF YOU HIT A SHOT THAT CROSSES OVER THE OUT OF BOUNDS MARKING (STREET CURBING)
 ON HOLES #3, 6, 9, 13, 15, 16, 17, OR 18 AND COMES TO REST BACK ON THE GOLF COURSE
 ACROSS A ROAD OR ANOTHER BOUNDARY MARKER, YOU ARE STILL CONSIDERED OUT OF
 BOUNDS.
- 4. THE DRIVING RANGE NET ON HOLE #8 IS CONSIDERED TO BE THE OUT OF BOUNDS MARKER. NO RELIEF IS GRANTED.
- 5. DROP ZONES HAVE BEEN ADDED, AND **MUST BE USED,** FOR BALLS THAT COME TO REST IN THE ENVIRONMENTAL AREAS NEAR #5 AND #7 GREENS. THERE IS ALSO AN **OPTIONAL** DROP ZONE FOR BALLS THAT END UP IN THE HAZARD BEHIND #7 GREEN.
- 6. USGA RULES GOVERN ALL PLAY UNLESS MODIFIED BY LOCAL RULES.
